The importance of studying resource science of medicinal plants





The study of resource science of medicinal plants is caused by the need for the practical implementation of the procurement of medicinal plant raw materials, as well as the organization of the rational use and timely reproduction of phytoresources, which is necessary for obtaining medicinal plant products. • The object of direct work in resource science of medicinal plants is specific types of medicinal plants that are sources of raw materials











What we will study

- > species of medicinal plants growing in the world, which are the source of raw materials from which herbal medicinal products are produced: life forms, influence of geographical and ecological factors on their development, areas of growth, characteristics of the raw material base
- the main types of plants included in the Red List
- regulatory and legal bases for the use of medicinal plant resources





- rules for determining productivity, operating reserves and possible annual harvests
- organization and general rules of procurement, drying and storage of medicinal plant raw materials
- main procurement organizations and their functions
- a system of state measures for the rational use and protection of medicinal plant
- methods of accounting for medicinal plant resources
- resources, taking into account current environmental legislation and regulatory acts
- safety rules when working with medicinal plant and medicinal plant raw materials
- the system of standardization and certification of medicinal plant raw materials, herbal medicinal products in Ukraine; documentation of medicinal plant raw materials analysis results; legal meaning of the certificate



- ➤ to navigate the modern problems of ensuring the pharmaceutical production of medicinal plant raw materials
- ➤ predict and find promising plant species sources of specific biologically active substances
- > to estimate stocks of medicinal raw materials in specific thickets
- ➤ to develop and forecast the effectiveness of a rational mode of use and restoration of plant resources
- > organize and carry out procurement, acceptance and standardization of medicinal plant raw materials
- ➤ carry out a set of measures aimed at the storage and propagation of thickets of medicinal plants and plants included in the Red List
- rocessing and storage of medicinal plant raw materials
- ➤ to calculate the yield, operational reserves and annual possible harvesting of wild medicinal plants
