Department of Pharmacognosy and Nutriciology of the National University of Pharmacy of the Ministry of Health and the Ministry of Education of Science of Ukraine invite you to participate in the VI International Scientific and Practical Internet-Conference **«Current approaches of pharmaceutical science in development and standardization of medicines and dietary supplements that contain components of natural origin»**, which will be held on April 12, 2024.

The Conference is included into the Register of Congresses, Symposia and scientific and practical conferences of 2024 (*UkrISTEI certificate № 600 from 11.12.2023*).

CENTRAL AREAS OF FOCUS OF THE CONFERENCE

- Analysis of the market of herbal medicines, dietary supplements, medical and preventive, and cosmetic remedies;
- The search of new sources of medicinal plant material for the creation of medicines and dietary supplements;
- Standardization of medicines and their pharmaceutical analysis;

- Current approach to the technology of herbal medicines;
- Analysis of extemporal medicinal forms on the basis of plant-derived components;
- Pharmacological research of plant-derived medicines, determination of safety of dietary supplements.

Virtual (only abstract publishing).

LANGUAGES OF THE CONFERENCE

Ukrainian, English.

ABSTRACT SUBMISSION

The abstract should be prepared in the word processor Microsoft Word (*.doc or *.docx).

All margins 2 cm, font Times New Roman, font size 14, spacing – 1,0, paragraph indentation – 1,25 cm, spacing before and after paragraph – 0 pt (absent), full justification.

Total size of an abstract (A4 format), including tables, pictures and references should be 1-2 **full** pages.

Word and term shortenings in the title of abstract are not allowed; complete forms of shortenings in the text are given after the first mentioning. The International System of Units (SI) should only be used in the abstract.

The abstract heading includes: first line – abstract title (capital letters, bold), second line – last names and initials of the authors are separated by comma (bold italics), third line – full title of the organization (bold italics). The body of the abstract is given after one line.

The abstracts should contain the following parts: introduction, materials and methods, results and their discussion.

After the body of the abstract the list of references is given (not more than 5 sources in alphabetical order). The references are given in the text using the number of the literature source in square brackets.

Chemical structures are given in IsisDraw format, mathematic – using the built-in editor Microsoft Equation, pictures – in *.cdr format (versions not higher than X8), *.jpg or *.tiff.

Abstracts formatted according to the requirements should be sent before **April 11, 2024** to the e-mail address **cnckonf2018@gmail.com**.

One file should contain one abstract. The file names should correspond with the name of the first author (e.g., Petrov A.A.doc). If more than one abstract is submitted by one author, the files should be numbered with arabic figures (e.g., Petrov A.A.1.doc).
